**THE PARTIES HERETO AGREE AS FOLLOWS**

This breeding is not to be sold or transferred without the written permission of the **Stallion Owner** but may be carried into the next breeding season if the mare needs to be rebred and once the **Stallion Owner** has been notified.

**FEES - All amounts paid by the Mare Owner shall be non-refundable, subject to BREEDING or AVAILABILITY OF FRESH SEMEN sections here of this agreement**

**1. The Fresh Semen Breeding Fee is Euro 4000 with all bank charges being paid by the mare owner.**

**2. The breeding fee is payable upon signing of this contract to the provided back account.**

**3. All shipping and semen handling costs are to be paid by the Mare owner.**



## **BREEDING**

1. This breeding contract entitles the **Mare Owner** to one breeding to **RFI Farid** with one breeding certificate being issued per contracted mare.
2. In the event the contracted mare fails to conceive within three (3) heat cycles the **Stallion Owner** reserves the right to require the contracted mare to be cultured or biopsied to determine breeding soundness. The **Stallion Owner** also reserves the right to refuse service to any mare upon detection of an infectious and/or contagious disease. In the event of such discontinuance, the **Mare Owner** is obligated to substitute another mare to fulfill the terms of this agreement.
3. **Mare Owner** is obligated to notify the **Stallion Owner** of failure to conceive within 60 days of season end in order to be eligible to rebreed.
4. Should the contracted mare become ill, injured or is otherwise unable to conceive a foal the **Mare Owner** may substitute the mare with prior consent of the **Stallion Owner**.
5. In the event the mare dies, **Mare Owner** shall provide **Stallion Owner** with a veterinary certificate of death in order to claim a rebreed with a substituted mare.

## **AVAILABILITY OF FRESH SEMEN**

1. Should the semen become not available, due to lack/ or loss of due to unforeseeable circumstances, before the contracted mare is first serviced pursuant to this agreement, **Stallion Owner** will refund entire fee.

## **LIVE FOAL GUARANTEE**

1. Al Hawajer Stud guarantees a return breeding within this breeding season or the following season either for the contracted mare or an approved substitute, should a live foal (defined as one that stands and nurses without assistance for 24 hours) not result from this breeding.
2. Should the foal be born dead or die before standing and nursing without assistance for 24 hours of birth, written statement from the **Mare Owners** licensed veterinarian stating the time



and date of birth and the time and date of death shall be sent to the **Stallion Owner** within two (2) weeks of foals death.

### **INDEMNITY**

Al Hawajer Stud, as **Stallion Owner** and its owners, agents, employees, veterinarians shall not be liable for any sickness, disease, theft or injury which may be suffered by the contracted mare and/or resulting foal and/or semen during the breeding period of the contracted mare.

This contract constitutes the entire agreement between both parties and may not be modified except in writing and agreed upon by both parties.

### **LAW**

This contract is governed by and construed in accordance with UAE law.
